**EMERGENCY OVERVIEW**

**4. FIRST AID MEASURES**

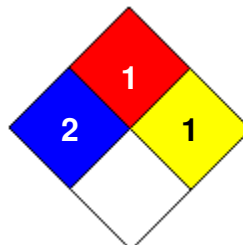

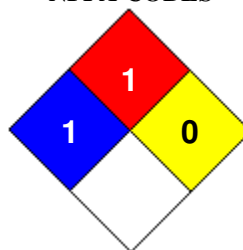
