# SC-22 POLYURETHANE SOFTENING AGENT

SC-22 is a softening agent that allows the end user to adjust the hardness and elongation properties to their desired characteristic.

## **APPLICATION:**

SC-22 can be added to any of BJB's Polyurethane Elastomers. We would not recommend the addition of more than 100% of SC-22 to the total mix of the A & B polyurethane system. Higher levels can significantly reduce the cured physical properties and cure time of the polyurethane. Increased levels of surface tack may also occur with increasing amounts of SC-22.

## **STORAGE**:

Store at ambient temperatures, 65-80°F (18-27°C). Unopened containers will have a shelf life of 6 months from date of shipment when properly stored at recommended temperatures. Purge opened containers with dry nitrogen before re-sealing.
